DRONES IN CONSTRUCTION

Drones are extremely versatile. They can fly from a few inches from the ground up to 400 feet panning or framing a chosen subject, move left, right, up or down or rotate on the same spot because the pilot has a real time visual of the object under surveillance. The quality of the pictures is outstanding as they shoot in full HD.

An aerial view of property allows for a unique perspective of a site's overall condition, surrounding properties, water features, roadways and other elements critical in decision making for acquisition and development. Due to their size drones are able to fly into areas that may be inaccessible or hazardous to assess structure and land conditions.
