Safety Forum: OSHA Crystalline Silica Rule

OSHA's new construction standard for respirable crystalline silica is now in effect and requires employers to limit worker exposures to respirable crystalline silica and to take steps to protect workers. This talk will explain the standard and discuss what employers must do to comply with the regulation.
